

RECOMMENDED MESSENGER SERVER REQUIREMENTS

Operating System

- Liaison Messenger Server: Any version of Windows (server or client) from 2000 to current version (32 or 64 bit operating systems)
- Liaison Messenger Client: Any version of Windows (32 or 64 bit operating systems)

Minimum Hardware Specifications

- Disc space: 100 MB
- 6 GB ram or greater

OPTIONAL EMAILING AND ARCHIVING REQUIREMENTS (8 Options) - To be installed at the Messenger server.

- One of the following: Microsoft Outlook, Outlook Express, Microsoft Mail - installed on the Messenger server machine.
- Office 365 (Messenger EDD only)
- SMTP Server (Messenger EDD only)
- Gmail (Messenger EDD only)
- Eudora
- MAPI compliant e-mail client
- Novell Groupwise
- Lotus Notes via Domino Server. Requires one Outlook client installed on the Messenger server to communicate with the Domino Server.

OPTIONAL FAXING REQUIREMENTS (9 Options) - Messenger sends faxes utilizing one license of Outlook at Messenger Server thru PDF attachment.

- Output to internet based fax service via email, examples: myfax.com, send2fax.com, nextiva.com, efax.com
- Rightfax w/ Outlook client add-in & PDF module
- Castelle FaxPress w/email gateway
- FACsys with Outlook client add-in
- Microsoft Fax Console, included in Windows XP and prior operating systems requires Acrobat Reader 6.0
- Microsoft Windows Fax & Scan, included with Vista, Windows 7 and Windows 2008 requires Acrobat Reader, up to current version of 10.0
- GFI Faxmaker with Outlook client add-in
- FaxFinder by MultiTech with Outlook client add-in
- Additional 3rd party solutions that offer Outlook client add-in

(A dedicated telephone line is strongly recommended with Microsoft Fax Transport and Windows Fax & Scan)

LIAISON MESSENGER SERVER IN A HOSTED ENVIRONMENT

Liaison Software Corp requires a special end-user license for Hosted/Leased environments

When Liaison Messenger Server is being hosted on a remote system, it can only be configured using a remote control type program, i.e. gotomeeting.com,

* Messenger FORM users - Liaison Messenger Client can be utilized thru a Citrix or terminal server session or similar programs.

FORM TEMPLATE MODIFICATIONS FOR EXISTING DYNAMICS GP RUNNING LIAISON MESSENGER FORM-ONLY

Liaison will modify form templates (1 of each form - Invoice, Sales Order, Purchase Order, Statement) to match the clients existing GP business forms at no charge. Additional fee for giving access to extender or external data that needs to be viewed on a form (1 hour per table at 150.00/hr, avg)

For Liaison to modify forms, please provide the following:

- Original Crystal report or GP package file
- Output samples either faxed or emailed as a PDF
- Be sure to note any special fields or criteria, i.e. suppression, etc.
